# Stages of a bill

- Introduction
- First reading
- Consideration by select committee
- Second reading
- Committee of the whole House
- Third reading
- Royal assent

A committee of the whole House (CWH) considers a bill to determine whether it properly incorporates the principles or objects of the bill as read a second time by the House SO298(1)

- Opportunity for members who have not spoken in previous debates to speak to the bill.
- Time when the final proportionality of the House is brought to bear on the text of the bill.
- Function of the committee is to make any amendments to the bill's text that may be found desirable before it proceeds to be passed by the House.

#### Order of consideration

- Preamble (if any)
- Part by Part
- Schedules
- Preliminary provisions

Instruction by House

**Business Committee determination** 

#### Amendments are ruled out of order if

- outside the scope of the bill
- omnibus in nature
- inconsistent with previous decision
- not serious, vague, lacking in form
- seek to amend agreements or treaties
- should be dealt with by private or local legislation

 SO 297 requires Government, where practicable, to notify that it intends a bill to progress to the CWH stage in the following week
